SUMMARY ANNUAL REPORT FOR NATIONAL ROOFING INDUSTRY SUPPLEMENTAL PENSION PLAN

This is a summary of the annual report for National Roofing Industry Supplemental Pension Plan, EIN: 36-6157071, for the year ended December 31, 2007. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by the Trust.

Plan expenses were \$98,735 consisting of \$56,264 in benefit payments to participants and \$42,471 in administrative expenses. A total of 1,269 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The value of the plan assets, after subtracting liabilities of the Plan, was \$6,305,004 as of December 31, 2007, compared to \$4,702,259 as of January 1, 2007. During the Plan year, the Plan experienced an increase in its net assets of \$1,602,745. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$1,701,480 including (but not limited to) employer contributions of \$1,453,081 realized losses of \$91 from the sales of assets and earnings from investments of \$248,490.
