The minutes of the January 20, 2008, meeting at the Holiday Inn on the Bay in San Diego, which were previously mailed to all the delegates, were approved as submitted.

### REPORTS OF DELEGATES

**Rick Wildebaur, Local 27**, said work is starting to pick up now that the schools are bidding. AJ Fetko was signed to a one-job agreement to do asbestos roof removal. A company called D-7 is moving into the Fresno area. Local 27 is now on the International software and it works very well, especially for mailers.

**Joe Guagliardo, Local 27**, has

been busy in his capacity as compliance officer. He filed a complaint with the labor commissioner on Midwest Environmental Inc., an Ohio company with a shop on Edwards Air Force Base, for nonpayment of roofers' wages, subsistence and travel time. He also filed a complaint against California Commercial Roofing Systems of Oxnard - Tulare for nonpayment of travel time and overtime.

**Raul Melendez, Local 36**, said work is good, and they are getting ready for negotiations. With the help of Organizer George Corona, they signed F. Rodgers to a full master labor agreement.

**Steve Tucker, Local 40**, said they are doing compliance on all contractors, union and non-union. They pick a job before it's awarded and then follow up with the compliance. They are also doing random audits. Local 40 has a PLA with the San Francisco Unified School District. State Roofing Services and Legacy Roofing are installing a lot of solar panels in the area.
