### **2023: A Year of Challenges and Opportunities**

very challenge we face is an opportunity to grow. Remember that as we enter the new year. Our primary challenge this year will be responding to the demands for qualified roofers and waterproofers. The potential for work opportunities for our contractors and members is the highest we have witnessed in decades. Opportunities of this magnitude do not occur often, and taking advantage of these times is critical to strengthening and growing our union and improving the lives of our members. Employers in all industries are confronting labor shortages, so competition for a qualified workforce is at an all-time high. But this challenge is an opportunity to grow that we cannot ignore.

Our second challenge leads up to October of this year, when our union will hold its Thirtieth Convention celebrating 120 years of history. The convention is not about celebrating the past, however; its objective is plotting the course for the future. Every five years, local unionelected convention delegates are charged with making decisions regarding the path we as an organization will take going forward. The challenge here is charting a course of action that will enable us to not only respond to labor shortages, but protect our historic work jurisdiction—one that will strengthen our union and improve our members' opportunities to earn a good living.

This convention, the theme will revolve around leadership training. The International Union has drastically improved training for newly elected local union officers over the past few years and will continue to do so. The Leadership Training Program at Washtenaw Community College last year was well attended with positive reviews. We will continue investing resources into that program. In addition, we will continue to provide training programs at district council meetings upon request. In the very near future we will introduce a new training curriculum for local union executive board officers.

Why is local union leadership training important? Because progress and growth of our union occurs at the local level. Effective and educated leaders are visionaries seeking ways to secure work for their members, while increasing membership numbers to increase market share. This allows leaders to negotiate better wages, benefits and working conditions for members. Investment in the training, education and skillset of local union leadership is the most important step we can take in preserving and growing our union.

As we move towards the October convention, keep in mind the principle on which our union was founded: improving the lives of the roofers and waterproofers who toiled in our industry 120 years ago. The Preamble to our Constitution and By-Laws in part reads: "to broaden the scope of usefulness and extend the field of employment of each and every individual member; to protect and improve the economic conditions and quality of life of our membership and all working people, their families and their communities." Accomplishing this requires leaders who are willing to step up to the challenge and learn. Our members deserve it, as well as our union.

Why is local union leadership training important? Because progress and growth of our union occurs at the local level. Effective and educated leaders are visionaries seeking ways to secure work for their members, while increasing membership numbers to increase market share.



# WORKERS MEMORIAL DAY APRIL 28, 2023

### As we grieve those we have lost from unsafe working conditions, we will organize for safe jobs. We must:

- Guarantee all workers have a safety voice on the job and the right to freely form a union without employer interference or intimidation.
- Ensure all workers can select their own representative during an OSHA inspection.
- Increase efforts to protect Black, Latino and immigrant workers who are disproportionately affected by and especially targeted for speaking up against unsafe working conditions.
- Increase job safety budgets and improve job safety enforcement.
- Win new protections against heat illness, workplace violence, silica exposure in mining, infectious diseases, exposure to asbestos and other toxic chemicals, and other preventable hazardous exposures.
- Pass the Protecting America's Workers Act (PAWA) to provide OSHA protection to the millions of workers without it, stronger criminal and civil penalties for companies that violate job safety laws, and improved anti-retaliation protections.
- Defend hard-won safety and health protections and workers' rights from attacks.

### **PLAN AND SHARE** YOUR WORKERS MEMORIAL DAY EVENT

- Organize a campaign to call for stronger safety and health protections using our digital toolkit. Demand that elected officials put workers' well-being over corporate interests.
- Organize an event at your workplace to stand together to protect the fundamental right to a safe job for every worker and hold your employer accountable for keeping you safe.
- Hold a candlelight vigil, memorial service or moment of silence to remember those who have died on the job and highlight job safety problems in your community.
- Host an event with members of Congress in their districts. Involve injured workers and family members who can talk firsthand about the need for strong safety and health protections, the ability to speak up against unsafe working conditions, and joining together in union to keep workplaces safe. Invite local religious and community leaders and other allies to participate in the event.
- Conduct workshops to train and empower workers to report job safety hazards and exercise workplace rights. Invite union members, nonunion workers and community allies to participate.
- Create a new memorial site at a workplace or in a community where workers have been killed on the job.
- Create and share an online photo and storyboard campaign on social media to remember workers who have been killed on the job.
- Invite the press to your Workers Memorial Day events to increase public awareness of the dangers working people face on the job.
- Continue to hold our leaders and employers accountable to provide safe working conditions. As a labor movement, we mourn for the dead and fight for the living on April 28 and every day of the year.



As in the past, this convention promises to be exciting, motivating and constructive. As the union roofing and waterproofing industry—and our Union continues to forge ahead, we can look forward to a more prosperous future, one that will be shaped by your democratically elected representatives this October.

# TRADESWOMEN BUILD NATIONS RETURNS FOR LARGEST GATHERING EVER

3,300 TRADESWOMEN CONVENED IN LAS VEGAS FOR THE 2022 EVENT



n the weekend of October 28 – 30, 2022, more than 3,000 tradeswomen and allies gathered at the Paris Casino in Las Vegas, NV, for North America's Building Trades Unions (NABTU) Tradeswomen Build Nations (TWBN) Conference. TWBN is the largest gathering of any kind for union tradeswomen, and the largest NABTU event, eclipsing even the annual Legislative Conference.

After two years of virtual events due to the Covid pandemic, TWBN returned to the in-person format that has become a beloved tradition among women members of the building trades unions. Every year the (in-person) conference sets a new attendance record, and last year was no different, besting the previous record of over 2,800 set in Minneapolis in 2019. The yearto-year growth of this conference has been phenomenal and is not expected to slow.

The three-day conference focused on a theme of "Stronger Together" and included a number of workshops and notable professional and industry speakers during the two plenary sessions. AFL-CIO President (and IBEW member) Liz Shuler, NABTU President Sean McGarvey, and Secretary of Labor Marty Walsh were among the weekend's speakers, illustrating that this conference is able to draw the biggest voices in the labor movement.

The conference also offered opportunities to socialize and show union pride. In addition to a welcome reception and a Roofers dinner, attendees took part in one of the traditional highlights of











the weekend—the banner parade. This year's parade was Las Vegasstyle: energetic, fun, and over the top. Thousands of sisters and allies marched up and down the famous Las Vegas Strip carrying banners and loudly chanting. The spectacle was amazing and inspiring.

Marking the first time a Roofers international president has attended TWBN, President Jim Hadel spent the weekend watching speakers, marching in the parade, and generally getting to know all the Roofers and Waterproofers who made the trip out to Las Vegas. As he addressed the Roofers caucus, he implored every attendee to make it her mission to personally



recruit at least five more women into the trade to not only grow our union, but to help women have a stronger voice.

Roofers and Waterproofers represented 35 attendees from 15 local unions. While this is a strong showing from our union, there are hundreds of women on our rosters who are not being given the opportunity to meet, network, and find support with their tradeswomen sisters. We hope that this year's conference in Washington, DC, will have even greater turnout of Roofers and Waterproofers, and that our union will continue to recruit and retain the women who make our organization strong and diverse!

### MINUTES FROM THE INTERNATIONAL EXECUTIVE BOARD MEETING HELD ON JANUARY 24, 2023 · SCOTTSDALE, AZ

The meeting was called to order at 8:00 a.m. by President Hadel, followed by the Pledge of Allegiance.

At this time President Hadel read the International board call letter dated November 15, 2022, submitted by Secretary-Treasurer Mitchell Terhaar.

President Hadel started the meeting by reviewing the agenda for the day followed by the announcement of a personal appearance for Case 1756 by Travis Hopkins on behalf of Local 49, Portland, OR.

President Hadel reported on the work hours based on the Research and Education hours submitted as of November 2022.

President Hadel then discussed the total number of hours worked

over the last ten years based on NRIPP hours reported. The Executive Board discussed ways to improve overall membership growth and ways to increase work hours. An action plan will be shared with the locals at a later date.

President Hadel reported on the Local Union Leadership Training Program (LTP) that will be held June 12-16, 2023. He discussed the schedule for the week and the classes that will be held. The classes consist of: Basic Computer Skills, Cash Receipts Record (CRR) Training, Business Communications, Business Etiquette, Principles of Management, Labor Law in the Construction Industry and a Basic Accounting class. The classes will be offered to any local union officer who would like to improve their business skills.

President Hadel reported on the Union Veterans Council stating that the council was a division of the AFL-CIO but has recently branched out as an independent organization. With this change the per capita payment structure has changed and will be paid directly to the Union Veterans Council. A discussion was had in regards to the per capita increase and approved.

President Hadel reported that the NRIPP is currently funded at 113.4% for 2022 and the National Health & Welfare contribution rate increase has been waived for 2023. A letter has been sent out to the participating locals and their signatory contractors informing them of the health fund contribution holiday.

President Hadel reported on the following upcoming trade shows and conferences for 2023: North East Roofing Contractors Association (NERCA) trade show February 7-9, Uncasville, CT; North America's Building Trades Unions (NABTU) Legislative Conference April 23-26, Washington, DC; International Roofing Expo (IRE) March 7-9, Dallas, TX; Western States Roofing Contractors Association (WSRCA) trade show September 23-25, Las Vegas, NV; Midwest Roofing Contractors Association (MRCA) trade show October 18-20, Omaha, NE; and the annual NABTU Women's conference TBD, Washington, DC.

At this time, President Hadel called on Secretary-Treasurer Terhaar to review the following cases, which were brought before the Executive Board for their consideration and hearing.

**CASE 1756** — Appeal by Russ Garnett, #231439, member of Local Union 49, Portland, OR, from certain action taken against him by Local Union 49.

After a lengthy discussion, and after considering all evidence and the testimony in this matter, the International Executive Board sustained the appeal and overruled the decision of the Local 49 Trial Board and ordered a new trial.

CASE 1757 — Appeal by Orlando Castellon, #261429, member of Local Union 81, Oakland, CA, from certain action taken against him by Local Union 81.

Secretary-Treasurer Terhaar reported that the appellant to Case 1757 had requested to withdraw his appeal.

CASE 1758 — Appeal by Carlos Opfermann, #228071, member of Local Union 81, Oakland, CA from certain action taken against him by Local Union 81.

Secretary-Treasurer Terhaar reported that the appellant to Case 1758 had requested to withdraw his appeal.

President Hadel reported on his meeting with Executive Director McKay Daniels of the National Roofing Contractors Association (NRCA). They discussed the challenges within the roofing industry and the material shortages throughout the country. They talked about the great working relationship between the union and the NRCA and the need to keep that strong. There was a discussion by the board on NRCA membership and the annual cost. A motion was made, seconded and carried, with Vice President Ziegler voting no, to approve the annual membership.

President Hadel called on International Representative Kevin King to stand. He congratulated Brother King for his 25 years of service and accomplishments as a member of the United Union of Roofers, Waterproofers and Allied Workers and presented him with his 25-year pin and card.

President Hadel then reported on the Executive Board oversight training for all officers as part of the Leadership Training Program. This will become part of the International Representatives duties to ensure that all officers understand their roles and obligations as an officer of their union. This will be done on a biennial basis.

President Hadel reported that the theme for the 30th International Convention will be Leadership-Empowering the Future and that the Convention Fund is in good shape. In addition, the International office staff has been moving forward with convention planning.

There was discussion on Article V, Section 5 of the International Constitution on the expense money for the delegates and the need to increase it due to the higher cost of travel. After the discussion a motion was made, seconded and carried to approve to increase the expense money for each convention delegate to one thousand, three hundred and fifty dollars (\$1,350.00) plus ten cents (\$.10) per mile.

President Hadel then gave an overview of all resolutions submitted as of January 25, 2023. He called on General Counsel Librado Arreola to discuss and review Resolution #1 and #2 with his updates and suggested changes to the International Constitution and By-Laws. After reviewing both resolutions General Counsel Arreola will make the suggested changes and present them at the next Executive Board meeting.

Resolution #3 regarding Article II, Section 5 of the International By-laws. After discussion was held, more information was requested by the Board and will be presented at the next Executive Board meeting.

Resolution #4 Support for ERT. After discussion was held, a motion was made, seconded and approved as written.

Resolution #5 regarding Supporting Diversity in our trade. After discussion was held, a motion was made, seconded and approved as written. Resolution #6 regarding Supporting John Martini Organizing Award. After discussion was held, a motion was made, seconded and approved as written.

Resolution #7 regarding Support for Union Sportsmen's Alliance (USA). After discussion was held, a motion was made, seconded and approved as written.

Resolution #8 regarding support for Project Labor Agreements (PLAs). After discussion was held, a motion was made, seconded and approved as written.

Resolution #9 regarding support for National Maintenance Agreements (NMAs). After discussion was held and revisions made, a motion was made, seconded and approved.

Resolution #10 regarding support for Helmets to Hardhats (H2H). After discussion was held and revisions made, a motion was made, seconded and approved.

Resolution #11 regarding Article VI, Section 2 of the International Constitution. After discussion was held, more information was requested by the Board and will be presented at the next Executive Board meeting.

Resolution #12 regarding Article IV, Section 3 (f) of the International By-Laws. After discussion was held there was a recommendation to increase the sum from five thousand dollars (\$5,000.00) to six thousand dollars (\$6,000.00). After revisions were made, a motion was made, seconded and approved.

Resolution #13 regarding Zero Loss-time injuries. After discussion was held, a motion was made, seconded and approved as written.

Resolution #14 regarding Suicide Prevention. After discussion was held and revisions made, a motion was made, seconded and approved. Resolution #15 regarding the use of Opioids. After discussion was held, a motion was made, seconded and approved as written.

A discussion was had pertaining to Article V, Section 6 and 7 of the International By-Laws regarding re-enrollment and retirement per capita fees.

President Hadel continued his convention report by asking the Board to encourage the locals to send in pictures of members to be used at the convention. He reported that the credentials, resolutions and agenda will be digital and that an iPad will be provided for each delegate.

President Hadel ended his convention report by appointing Vice President Gary Menzel to serve with Vice President Paul Bickford and Mike Stiens on the Entertainment Sub-Committee.

President Hadel reported that the International staff are currently working on the development of an electronic membership application and hope to have it ready for the locals soon.

President Hadel reported on the National Apprentice Competition saying that a committee has been established to develop rules and an outline for the competition. A start date has been set for May 2024. President Hadel expressed the importance of encouraging the locals to take part and to get their apprentices involved. The winners from each regional council competition will then take part in the national competition.

President Hadel called on Vice President Mike Vasey to give his report.

Brother Vasey reported that Rebuild USA is highlighting infrastructure and the apprenticeship programs with online videos, which are showing wide success. They have released weekly legislative work done by the Democratic Congress and President Biden and are increasing the visibility of Rebuild USA and the Building Trades overall. Moving forward the committee will take its success patterns and expand the general and overall goals nationally. Rebuild USA is doing a great job with communication to the union membership.

Brother Vasey then gave a brief overview of his local unions and the Mid-States District Council. The locals' membership numbers have grown in his area and with the workload coming into Ohio they feel it will add to the numbers. The locals have increased their starting wages to help with the recruiting of new workers for their signatory contractors. Lastly, Brother Vasey said that the Mid-States District Council had their election of officers and that they ran unopposed.

President Hadel called on Market Development Director Jeff Eppenstein to give his report.

Brother Eppenstein reported on the membership numbers for 2022 and 2023. He reported on the membership applications for this year and the number of emails received from our "becoming a member" website. He gave a progress report on the marketing team and their focused efforts on recruiting. He gave an update on the success of the Puerto Rico marketing drive. Lastly, Brother Eppenstein finished his report by speaking about the partnership they have developed with GAF Roofing Academy and how they have been working together to recruit roofers to the industry. This program has provided new members for our local union contractors.

President Hadel called on Executive Director Keith Vitkovich of the Roofers and Waterproofers Research and Education Trust Fund to give a report on the Trust Fund's initiatives.

Brother Vitkovich began speaking about the status of the Trust Fund directly providing OSHA 510, 500 and 502 courses that are required for those seeking to become or continue to be outreach instructors that will have the capabilities to instruct OSHA 10 & 30-hour outreach classes. He continued this discussion stating that every local/JATC should have at least one outreach instructor that has the capabilities to provide this training to its local members.

He then reported that registration for the 2023 National Instructor Training Program will be sent out during the first week of February and registration will be closing during mid-March. He then reported that the Trust Fund has developed new brochures that provide more detailed information about the Fund's actions and capabilities.

Lastly, Brother Vitkovich reported that the Roofers Safety and Health program booklets that can be utilized by instructors providing OSHA 10 and 30 hour courses are now available in Spanish and they are now in the process of having the electronic presentations translated.

President Hadel called on Assistant to the International President Jordan Ritenour for his report.

Brother Ritenour reported on a jurisdictional issue with another NABTU union on roof removal. He has been working with a representative of the other union to resolve this issue. He then reported on the multi-billion dollar projects being built under NMAs and PLAs in the Midwest area and the demand that this will put on the local unions for manpower. President Hadel called on Secretary-Treasurer Mitch Terhaar for his report.

Brother Terhaar reported on the local union audits stating that there are no delinquent audits at this time. There are three contracts that need to be signed, two in Michigan and one in Arizona.

Brother Terhaar then gave a brief report on the trusteeship of Local 248. He gave an update on the local's membership numbers, the work hours for 2022 and the financial statements for the local. He reported on the Pension Trust Fund and stated that they will be filing for special financial assistance with the American Rescue Act in March. Brother Terhaar finished up with a report on the conditions of the other trust funds and their financials.

Brother Terhaar then reported on the Emergency Response Team (ERT). The program has helped several families since it has been established. He reported that Fred Gee has been hired as Assistant Director to support and assist overseeing the program. Brother Terhaar then reported that they're looking to add two new responders this year and training is scheduled for August 2023. Lastly, they are currently in the process of updating manuals and marketing materials.

Secretary-Treasurer Terhaar read a draft submitted by General Council Librado Arreola of the Rules for the Submission of Resolutions to the 30th International Convention to the Board. A motion was made, seconded and carried to approve the draft as presented.

President Hadel reported on an upcoming organizing meeting in the Northwest region to discuss jurisdictional problems with the UBC. This meeting will include all business managers from the local unions in this area to discuss strategies to protect our work.

At this time President Hadel called upon Secretary-Treasurer Terhaar to review the assignments made since September 1, 2022. Following the review and corrections notated, a motion was made, seconded and carried to approve all of the assignments.

President Hadel called on Vice President Paul Bickford for his report.

Brother Bickford reported on his signatory contractors stating that work is good but manpower is going to be an issue. The local has added two new contractors and all Collective Bargaining Agreements are signed at this time.

President Hadel called on Vice President Bob Peterson for his report.

Brother Peterson reported that work is good in their area and that providing manpower will be an issue. Both Locals 149, Detroit, MI, and 70, Ann Arbor, MI, have been working well together with the jurisdictional boundaries. Under the NMA work in the state of Michigan the Building Trades have been discussing on how to deal with the drug policies in the agreements due to law changes in the state.

President Hadel called on Vice President Mike Stiens for his report.

Brother Stiens reported that Local 136, Atlanta, GA, had their local union election and have sworn in the new officers. They have moved the local out of trusteeship and into supervision for a 12-month period. The local has paid all financial obligations and is current with the International.

President Hadel called on Vice President Joe Pozzi for his report.

Brother Pozzi reported he has been assisting with the Leadership Training at several local unions. He's been proactive working with the locals on organizing tactics, attending bid openings and prejob meetings. He ended his report stating that the UBC is still actively stopping at the signatory contractors' job sites in the Indiana area.

President Hadel called on International Representative Kevin King for his report.

Brother King gave an update on the local unions in his jurisdiction. Local 182, Cedar Rapids, IA, and 142, Des Moines, IA, have been working on their apprenticeship programs and Local 97, Champaign, IL, will start teaching within the week. Local 32, Rock Island, IL, had some records destroyed from water damage at the facility they are renting and are working on preserving what documents they can.

President Hadel called on International Representative Leo Marsura for his report.

Brother Marsura thanked President Hadel and the Executive Board for their support and trust to appoint him to the International Representative position for the Northwest. He then gave an update on the locals he represents. He has been working with a new representative at Local 189, Spokane, WA, to acclimate him to the business manager position. Lastly, he ended his report by discussing Local 49, Portland, OR, and 58, Colorado Springs, CO, business. President Hadel called on International Representative Jim Brown for his report.

Brother Brown gave a report on the local unions he represents covering issues that they are having at the locals. He said that the locals have a lot of work coming up on the East coast and see manpower as the biggest hurdle this year. He discussed the need to improve the apprenticeship training programs at the locals to assure quality trained roofers. Lastly, he has been helping with the trusteeship at Local 248, Springfield, MA, and working with the membership to find an organizer for the local.

President Hadel called on Vice President Gary Menzel for his report.

Brother Menzel reported on the passing of the Illinois constitutional amendment protecting collective bargaining within the State and thanked all that helped support it. He stated that this will now guarantee workers the right to collectively bargaining in the state of Illinois. He discussed an ongoing jurisdictional issue in downtown Chicago over boom truck licensing. He then discussed the political fight for the position of Mayor of Chicago and the candidates that are running. Lastly, Brother Menzel discussed their organizing efforts in the Madison, WI, area and the training that is being done at the new apprenticeship facility in Milton, WI. Brother Menzel hopes to sign a contractor to the Madison agreement soon.

President Hadel called on Vice President Brent Beasley for his report. Brother Beasley reported on the heavy workload in the western region. He has conveyed to the locals the importance of providing the manpower for the contractors. He reported on the newly elected Business Manager Peter Lang at Local 40, San Francisco, CA, and gave an update on political efforts they are working on in the area.

President Hadel called on Vice President Dan O'Donnell for his report.

Brother O'Donnell reported on the new union facility and open house Local 2 recently held. They received positive reviews on the new training center and will be hiring new trainers for the apprenticeship program. Lastly, Brother O'Donnell discussed issues with the UBC and their signatory contractors.

President Hadel asked for a motion to approve all bills for the Executive Board meeting. A motion was made, seconded and carried that the bills and costs deemed necessary and proper relating to the scheduled meeting be approved in accordance with the authority in Article VII, Section 14 of the International Constitution.

There being no further business to come before the Board, the meeting was adjourned.

### Our Union's Elected Positions and Why They Matter to You

**B** rothers and Sisters, Despite your convictions, the sentiment that providing the power of a group to decide the future of your organization is easy to agree with. As a labor union, we firmly believe in making decisions and plans collectively instead of siloing away from those we serve. This is why electing the right people in our leadership roles is so vital to the future of our organization.

Every three years, your local union holds an election to choose officers per your constitution and by-laws. These elections determine the next round of officers, including the **President**, **Vice President**, **Business Manager/Financial Secretary/Treasurer**, **Recording Secretary, Trustees**, and **Sergeant at Arms**. The positions may vary from local to local, but the fact remains that when the cycle ends, the union members are called to fill what's needed to push their organization forward.

That's where you, a member of this union, come into play. Once elected, these officers will oversee your local union's day-to-day operations. They will sit on your health and welfare fund and pension fund board for the next three years! They will oversee negotiations for your contracts and even manage the apprenticeship training. As union officers, they play a vital role in the protection and security of your livelihood and that of your family.

To secure the right votes and choose wisely in the election process, it's essential that you're equipped with the proper knowledge of how each of these roles function. After all, it was Einstein who said, "Any fool can know. The point is to understand." So, let's take a closer look at what you're voting for.

### President

This office is responsible for oversight of the chapter/organization. The officer will ensure that the organization's mission and goals are upheld and kept center focus with every decision and plan.

### **Vice President**

Like the president, this office will support the oversight regarding the plans and decisions made. The vice president will support the president and assist with leadership and direction for the organization.

### Business Manager/ Financial Secretary/ Treasurer

ATTENTION: District councils, local unions, JATCs and signatory contractors—the GAF Roofing Academy is making a multimilliondollar investment in recruiting veterans, women, job corps students, recovery residents, and people from underserved communities onto a path to good-paying roofing and waterproofing careers.

For seven years the GAF Roofing Academy has marketed and recruited people all across the country to attend a 1-2 week class that lays out a basic understanding and hands-on application geared to residential, commercial, sales and warehouse skills. ### What is RF Radiation?

CPWR CONSTRUCTION RESEARCH AND TRAINING

Radiofrequency (RF) radiation, a type of non-ionizing radiation, is the energy used to transmit wireless information. At low levels it is not considered a hazard. But at the levels produced by telecommunications equipment, including radio, television, and cellular antennas, RF radiation can "pose a considerable health risk"<sup>1</sup> for workers. As demand for cellular and wireless services grows, more of these antennas are being placed on rooftops and sides of buildings. Many are disguised to hide their presence.

### What to look for...

Antennas that generate RF radiation come in different shapes and sizes and emit RF radiation in different directions. **Rectangular panel antennas** or dishshaped transmitting antennas\* generally send out RF radiation in one direction. **Cylindrical or rod-shaped antennas** emit RF radiation in more than one direction up to 360 degrees. **Hidden antennas** are designed to blend into their surroundings. They can be stand-alone (e.g. a flag pole) or a panel that blends into the side of a building, chimney, rooftop, or sign. These antennas are harder to identify and make it difficult to determine the RF radiation emitting direction.

### Are you in danger?

Do you perform work where telecommunications antennas are present? If the answer is **YES**, then you could be exposed to hazardous levels of RF radiation.

### Why it's dangerous...

- RF radiation is invisible.
- Power levels vary. The amount of RF radiation can be low when you start working and then spike to higher levels without warning.
- Symptoms are often delayed. By the time you feel the symptoms, such as overheating, reddening of the skin, and burns, you have already been over-exposed.
- Your risk increases the closer you are to the antenna and the longer you work in the RF radiation field.

RF radiation may interfere with medical devices (e.g. pacemakers), and concerns have been raised about possible non-thermal effects (e.g. nerve damage and psychological injuries).

### Know the basics...

**Ask questions** Ask your supervisor if cellular antennas or other RF radiation generating antennas are present. At a minimum, do your own visual assessment. The building owner or property manager should have, or know whom to contact for, information on the antennas, their locations, and the RF radiation levels.

# **Follow instructions** When RF radiation is present, warning signs should be posted that include information on the hazard and a point of contact for information on the antenna. If you need to work within the RF field, the antenna owner should move or temporarily power down the device.<sup>2</sup> Ask your supervisor to confirm it's been powered down before proceeding.



**Seep your distance** Avoid standing right in front of or close to antennas. If there are antennas where you are working or on buildings close by, make sure the antennas are not pointed directly toward your work area. At a minimum, stay 6 feet away from a single antenna or 10 feet away from a group of antennas. A personal RF monitor and/or RF protective clothing may be needed. A monitor should sound an alarm if you are in an area where RF radiation is at a dangerous level. Protective clothing will shield you up to 1,000% of the FCC's maximum permissible exposure limit (MPE). It will not protect you from electrical shocks or arc flash.

### If you think you are in danger:

Contact your supervisor. Contact your union.

### **Call the antenna owner**

The contact information should be listed on the warning sign(s) or provided by the site owner/manager. Tell them you are a construction worker, describe the work you will be performing near the RF radiation generating antennas, and express your concern about an exposure hazard. Request a site power down for any work performed within the hazardous area or written confirmation that it is safe to perform work as described without a power down. If there are multiple antennas, repeat this process with each antenna owner.







NRIPP is funded at 113%, which is great. Please send pictures of members doing waterproofing work. Protect your work at all costs.

Attend job fairs and try to get your apprenticeship programs in these schools to reach out to the next generation of roofers. Send in pictures of members fishing/hunting for the magazine and jobsite photos for next year's convention in Las Vegas in October.

International Vice President Joe Pozzi will be visiting locals to help new business managers use all the tools at their disposal. Use public record information before going to pre-jobs to help ensure more work for your contractors. When receiving information make sure everything is the original document—don't accept any paperwork that has information marked out. International Representative Kevin King reminded attendees to give their school board information so they know if any contractors are bidding work in the area. Don't forget that safety is the number one issue—nothing is more important than going home healthy to our families at the end of the day.

Asst. Director of Market Development Bill Alexander said they are actively looking for members when they get laid off; no one should be on unemployment if they don't want to because there are really big projects in Indiana, Ohio, Kentucky. Also, contact the Marketing Dept. to have GAF come to your local and do some pre-apprenticeship training.

Marcus Bass, Local 26, gave the financial report. He then discussed having a booth at the International Roofing Expo. The local has been using Indeed for recruitment and it seems to be working pretty well. Nominations are coming up for a couple spots on their executive board.

**Brian Smith, Local 119**, said work is looking good and they have added a lot of members. They are working on some PLAs on some big projects. Looking to get retention numbers up for the apprenticeship program.

Josh Land, Local 119, said Chrysler is building a new plant and one of their contractors was awarded the project. They should be running 100+ workers on this job and the local will make sure to provide all the manpower the contractors could ask for.

Scott Cooper, Local 26, said carpenters are training TPO welding locally at their new facility trying to steal work as usual. The contract negotiations class in Chicago was very helpful.

Mike Durham, Local 106, discussed manpower needs and recruitment strategies. He discussed some contractors that he's been trying to get to sign a CBA, as well as upcoming NMA projects and how to handle contractors on NMAs that aren't signatory. **Ron Stiles, Local 75,** discussed the new three-year contract. They are moving to block training for apprenticeship class. He went to a big job fair trying to bring in some young blood.
