Leadership Focus 2025

🗖 he labor movement, in spite of their efforts, was disappointed extremely in the results of the national elections last November. After four great years of progress and support from the Biden administration and our friends in both houses of Congress, we are faced with uncertain times. The agenda of the newly elected president is not that of an administration willing to work with organized labor. Just read Chapter 18 (Department of Labor and Related Agencies) of the Project 2025 document to get a perspective on the potential destruction we face over the next four years.

For our union and our brothers and sisters in the union building trades, much is at stake. Davis-Bacon provisions (prevailing wage), project labor agreements on federally funded projects, the National Labor Relations Board (which safeguards our right to organize), the weakening of our registered apprenticeship programs through the introduction of Industry Recognized Apprenticeship Programs (IRAPs), and overall labor and safety standards designed to protect our rights and assure us of a safe work site—all are potential targets.

Through these trying times, remember that the gains of organized labor never came overnight. Our brothers and sisters over the past century literally gave their lives for the labor standards and middle-class lifestyle we benefit from today. Now all the gains made in the past are at risk as the current administration seeks to destroy democracy as it stands today.

However, history has shown that democracy will prevail. We have survived unfriendly administrations and congressional majorities who opposed unions. In turn, we flourish when those in power are pro-union. We made immense Support and work with local politicians and community leaders to gain their support for pro-union legislation, like PLAs. Educate them on the labor movement. Many of these local legislators eventually end up in our nation's capital as House and Senate representatives. In my experience, more can be accomplished for organized labor working with local-level legislators than on a national level.

We cannot be distracted by the far-right agenda in our nation's capital. We need to focus our efforts on what we can control. We can achieve progress and growth if we, as leaders, set our minds to it.

progress during the Biden administration, for example.

The election is over and we must move forward. Midterm elections will be upon us soon, where hopefully we can gain back House and Senate seats with labor-friendly candidates. Meanwhile, our local unions need to place their attention on what we do best. Focus your efforts on recruiting, organizing, policing your work jurisdiction, and marketing your union and training programs. We cannot be distracted by the far-right agenda in our nation's capital. We need to focus our efforts on what we can control. We can achieve progress and growth if we, as leaders, set our minds to it. Setbacks are a part of organized labor's history, and as always perseverance will pay off and the labor movement will triumph. As I have stated before, "this challenge is an opportunity for growth," and if approached with the right frame of mind, we will prevail.


LOCAL 162 ROOFERS REPLACE

LAS VEGAS CONVENTION CENTER roof system



Farrell Roofing successfully secured and completed a prestigious contract to reroof approximately 48 acres (2,093,454 sq.ft.) of the renowned Las Vegas Convention Center in Las Vegas, NV, as part of its \$600 million renovation.

This large-scale project demanded a comprehensive approach and precise execution, made possible by essential contributions and skilled workmanship provided by the members of Roofers & Waterproofers Local 162. The project incorporated three distinct specifications tailored to address various needs of the building's roofing system:




80 mil S327 Sika PVC RhinoBond System

This specification involved installing a re-cover system over the existing PVC membrane, including a 1/2" DensDeck cover board and an 80 mil S327 membrane. Utilizing the RhinoBond attachment method, the system provided superior wind uplift resistance and significantly reduced membrane flutter, ensuring the roof's durability and performance under Nevada's extreme weather conditions.

Tear-Off and Replacement

In areas where buried conduits were located beneath the existing membrane and insulation, Local 162 members executed a meticulous complete tear-off to expose and safeguard these crucial elements. Following the tear-off, the installation of 80 mil Sika PVC over a 1/2" DensDeck cover board provided a robust, longlasting solution meeting stringent building codes and performance standards.







Sikalastic RoofPro (LAM 4-Course Coating System)

A seamless, reinforced liquid-applied membrane coating system was expertly installed over the existing PVC membrane to reinforce and protect specific roof areas. This innovative approach enhanced flexibility and waterproofing capabilities, particularly beneficial for complex roof geometries and areas experiencing high environmental stress.

Awarded in February 2024 and successfully completed in November 2024, this project stands as a testament to Farrell Roofing's ability to manage and execute largescale commercial roofing projects efficiently, within tight timelines. Why Financial Reporting Matters

rothers and Sisters, Last year was filled with challenges and triumphs. Your hard work and commitment have been the driving force behind our success both on the job sites and at the local union office. Thank you for your hard work and dedication.

As we kick off 2025, this is a reminder that LM filing is required for labor unions and serves as a financial report to the Department of Labor (DOL). This form provides a comprehensive overview of a union's financial activities, including receipts, disbursements, and assets. It is essential for unions to file this form accurately to ensure compliance with the Labor-Management Reporting and Disclosure Act (LMRDA). It not only serves regulatory purposes, but also contributes to the internal governance of the union.

By documenting financial transactions clearly and transparently, unions can foster accountability among their leadership and strengthen the trust of their members. Failure to file this form on time can result in penalties, including fines and potential loss of union recognition, which can have long-lasting effects on the organization's operations and credibility.

While the LM filing is specific to labor unions, the 990 form is filed by tax-exempt organizations, including our local unions, with the Internal Revenue Service (IRS). This form provides a detailed account of the organization's financial status, including income, expenditures, and executive compensation. The 990 ensures that tax-exempt organizations are using their resources appropriately and provides transparency to the public regarding their financial health. Filing the 990 is not only a legal requirement, but also a best practice for our unions. Our local unions must prioritize the timely filing of both LM and 990 forms. The consequences of late or incorrect filings can be severe.

This year will also be the start of the new financial statement review for all the local unions. Resolution 16 was passed at the 30th International Convention to

amend the language of Article VI, Section 2 of the International By-Laws:

"An independent accountant shall report on the annual financial statement and such report and findings must be submitted to the International Secretary-Treasurer within one hundred and twenty (120) days following the end of the Local Union's fiscal year. Such reports must be made in a format acceptable by the International Secretary-Treasurer, and all such reports must be certified by the Auditing Committee on a form provided by the International Secretary-Treasurer."

For clarification, the financial statement review shall consist of the following:

- A compilation report from an outside accounting firm of the local union's annual financial statements.
- An Agreed Upon Procedures (AUP) report from an outside accounting firm which includes the following procedures:
 - · Review of monthly bank reconciliations for the entire period.
 - Review of salary increases during the period including proper approval.
 - Review of direct expense reimbursements including proper approval.
 - Review of credit card statements including charges and proper documentation supporting the business purpose of the expense.

The financial review has introduced four new agreedupon procedures for the year-end audit to ensure that our local union is properly filing and retaining all necessary documents.

In conclusion, the filing of the LM, the 990, and a financial statement review is essential for demonstrating compliance with all applicable regulations governing labor unions. Proper documentation and reporting ensure that unions operate within the law and maintain their integrity as representatives of their members' interests.

Thank you for your hard work and dedication.

Fossil Fuels, and More

ata centers, artificial intelligence (AI), electric vehicles, new manufacturing facilities—all of these entities are screaming for power. The demand for electrical power has recently exploded, and it is expected to continue growing as we build more industrial centers and bring manufacturing back to the U.S., thanks to President Biden's CHIPS and Infrastructure Acts. (Although funding for these projects may now be blocked by the Trump administration.)

The need for electric itself will not have much of an impact on us and our craft, but these new data centers and manufacturing facilities will have a huge effect on us. Even the new power houses will have some roofing and waterproofing on them.

President Biden was successful in getting an infrastructure act passed when he was in office, creating a multitude of construction projects that were starting to be bid on and even breaking ground.

New nuclear facilities are going to be built, with the first one breaking ground this spring in Kemmerer, WY. The Tennessee Valley Authority (TVA) is seeking permits to build new nuclear facilities in their area. These projects will take years to build. Meantime, there are serious discussions about building new coal- and gas-fired power plants. There is roofing on all of these, and we are excited about the potential to be roofing new facilities. Old nuclear facilities are even coming back online, which will also have roofing needs. All of this activity points to jobs for union roofers and waterproofers, as long as the funding is there.

Meanwhile, on the political front—WOW. We are in a whirlwind of a time. President Trump has forced people to resign from jobs they have had for years or decades, even though most federal government positions actually have a natural attrition rate of about 6% per year. What nobody knows at this time is how we, the American taxpayers, are going to pay for this government "buy-out" or if he even has the authority to do this. Lawsuits have been filed on behalf of the federal employees.

He, Mr. Trump, has by the same token fired Gwynne Wilcox from the National Labor Relations Board because she is too friendly to labor. Not only has a sitting NLRB member never been removed since its inception in 1935, but this move has rendered the NLRB useless due to the fact it cannot reach a mandatory quorum of three to issue any decisions on labor disputes. This is a blatant attack on us and the entire labor movement. Even

> though she was confirmed twice by the Senate and was the chairperson of the NLRB, Trump fired her and has gotten the federal government into another lawsuit, which she has filed, requesting that she be reinstated immediately so the NLRB can continue to function properly.

> President Biden was successful in getting an infrastructure act passed when he was in office, creating a multitude of construction

projects that were starting to be bid on and even breaking ground. Within the infrastructure act was a project labor agreement (PLA) requirement, which requires certain labor standards on projects of \$35 million or more. Almost immediately after Trump took office, a federal judge ruled that PLAs are illegal on federal projects. Current contracts with PLA language would still be honored, but it appears that PLA language will soon be removed from federal projects.

Hold on tight, this is a zealous, unrestrained, tumultuous political atmosphere that we are in at this time, one as we have never seen before. With the cabinet appointees and executive orders we have seen signed in the first months of this new presidency, it appears it is going to be a very interesting and long four years.





Marketing Issues

Raising the Roof: Membership Growth and Retention

s we embark on the new year, it is essential to reflect on our membership growth over the past two years. We would like to acknowledge the locals that have received the John C. Martini Award for "Excellence in Organizing" and commend those locals that have successfully increased their membership from 2023 to 2024.

To begin with, let us assess our total national membership figures. In January 2023, our union had 22,389 members, and we concluded the year with 23,247 members, representing an increase of 858 members and a growth rate of 3.84%. As of January 2024, we started with 23,249 members and gained an additional 457, bringing our total to 23,706, which equates to a 1.96% increase. Over the two-year period, this results in a total membership increase of 1,315 members, or 5.88%. It is important to note that this figure does not include all initiates across the country who are working for signatory contractors and actively paying off their membership dues; once they secure their membership cards, they will be added to the total membership count.

With the use of social media, industry partnerships, and on-the-ground marketing through QR codes on road signs, stickers, and jobsite visits, our applications have increased immensely. In 2022 we had 312 people apply throughout that year. In 2023 our number went

With the use of social media, industry partnerships, and on-theground marketing through QR codes on road signs, stickers, and jobsite visits, our applications have increased immensely. up to 492 people applying, and this past year we saw another significate jump as 987 people applied. In addition, through our affiliation with North America's Building Trades Unions (NABTU), 428 veterans reached out for more details about joining through the Helmets to Hardhats program, while another 60 people expressed interest in becoming a union roofer or waterproofer.

While recruitment numbers have been encouraging over the past few years, retention remains a significant challenge for our union and signatory contractors.

While recruitment numbers have been encouraging over the past few years, retention remains a significant challenge for our union and signatory contractors. In 2023, the International Office issued a total of 3,995 membership cards, followed by another 3,882 cards in 2024. While these figures are commendable, the retention of these new members has been insufficient. Specifically, during the same two-year period, we experienced the expulsion of 2,485 members in 2023, with an even higher number of 3,017 members expelled in 2024.

To gain further insights into this issue, the International conducted a six-month retention survey from November 2023 to April 2024, examining 1,232 expelled members, which included 673 apprentices and 559 journeyman workers. The survey revealed that 33.7% of respondents left the trade due to low wages, lack of stable work, or the physical demands of the job. Additionally, 23.4% of expelled members indicated they left only to reinitiate and return to local union rolls. 19.1% stopped communicating and did not respond to calls from the local or JATC. Lastly, 9.1% cited life events, such as divorce, financial hardship, incarceration, or substance dependency, as reasons for their departure from the trade.

As we navigate the challenges ahead, including current threats to project labor agreements (PLAs), right-to-work (for less) laws, anti-union legislation, Davis-Bacon/prevailing wage laws, and the dismantling of the National Labor Relations Board (NLRB), it is imperative that we remain steadfast in our efforts to recruit, train, and retain our membership to secure a prosperous future.

We would like to take this opportunity to recognize and congratulate the nine locals that have achieved a record-high membership total from 1996 to 2024. These locals will be honored with the John C. Martini Excellence in Organizing award. This marks our fourth year of recognizing outstanding achievement in this category, with the first awards presented in 2022. The achievements of these locals will be highlighted in an upcoming magazine to further acknowledge their dedication to organizing excellence:

The Lone Shingler

F or nine years, Katlyn Gretz has been climbing ladders and scaling rooftops in Wheeling, WV, as a proud member of Roofers Local 188. She's never known a world where her work was typical for women, but that never stopped her.

Katlyn had always loved working with her dad and with all types of tools, so naturally she gravitated towards the trades. But even with experience working in the heat-

ing and cooling industry in Florida, she could not get a job in Wheeling as an HVAC tech. So when TG Cupp & Sons Roofing gave her a chance, she dove in headfirst.

As the lone woman in the field, Katlyn was determined to change the mindset that women couldn't thrive in a maledominated industry. The men on her crew didn't see how she could possibly lift and carry bundles of shingles or climb slippery, steep roofs without fear. But she wasn't about to let anyone doubt her.

Over time, the skepticism faded and was replaced by grudging respect. She became a solid part of the crew, an expert in the field, and someone who could hold her own. Despite all her success, however, one thing never changed: she

was the only woman on the job. Every day, Katlyn was reminded that she was alone in a world where the men around her were part of a long-standing tradition. She couldn't always relate to their jokes and stories, but she never let it get in the way of her work. She didn't need to be part of their world outside of work to show them she belonged on the roofs alongside them.

It took years of proving herself, but Katlyn became indispensable while working at Kalkreuth Roofing and

Sheet Metal over the last three years. She had a knack for getting the job done faster, more efficiently, and with attention to detail. Whether it was new construction or a repair job, Katlyn was always the one who could be trusted with the difficult work.

But even with the respect she had earned, Katlyn often found herself isolated in the industry. She didn't always feel included at union meetings and social gatherings.

She considered leaving. She wondered if there would ever be someone to talk to who understood the unique challenges she faced. But she always decided to stay. Every roof she climbed was a reminder that her place was earned, not given.

Nine years later, Katlyn still shows up. She still does the work with a fierce sense of pride and refuses to take crap from anyone on her crew. She pushes through the moments of isolation. Her reputation is solid, and the younger apprentices look up to her now. They respect her not just for what she does, but for the strength it takes to keep going right alongside the men. She constantly speaks up for herself and demands this respect. Local 188 Business Manager Charles Gracik attests that she's a great worker who

consistently arrives and puts in quality work.

Although she wishes she weren't alone, Katlyn Gretz doesn't need to be surrounded by other women to validate her place in the world of roofing. She has learned that she belongs, not because of who's with her, but because of who she is—a woman who shows up, works hard, and leaves behind a trail of rooftops she has conquered, one shingle at a time. I commend Katlyn for her strength and compassion for her job and this union.

White House Summit on Extreme Heat

he White House's Climate Policy Office invited the Roofers & Waterproofers Research and Education Joint Trust Fund to participate in the first-ever White House Summit on Extreme Heat last year. The Heat Summit brought together local, state, Tribal, and territorial leaders and practitioners representing some of the communities fighting on the front lines of extreme heat—including affected workers, healthcare professionals, and emergency responders.

The summit provided an opportunity to discuss lessons learned from the year's heat season, the Biden Administration's work on heat mitigation and preparedness, and how to drive further locally-tailored and community-driven actions to address extreme heat. Juan Villalpando, member of Roofers Local 26 and part-time instructor for the Research and Education Trust Fund, had the opportunity to express concerns for roofers, waterproofers and other tradespeople.

More Instructors Complete OSHA 502

he Roofers & Waterproofers Research and Education Trust Fund offered and presented an OSHA 502 course at Washtenaw Community College in Ann Arbor, MI, from December 17–19, 2024. Master Trainers Richard Tessier and James Currie instructed the course.

This OSHA 502 course is designed for trainers who have previously completed an OSHA 500 Trainer Course in Occupational Safety and Health Standards for the Construction Industry and are authorized trainers in the OSHA Outreach Training Program. OSHA 502 provides an update on OSHA construction standards, policies, and regulations. Upon course completion students have the ability to demonstrate continued professional development in their field



by applying effective adult learning principles and interactive training techniques to clearly identify, define, and explain construction industry hazards and acceptable corrective measures as they continue to teach the 10- and 30-hour Construction Outreach Training Program classes.

Naloxone Info Sheet for the Construction Sector

The construction sector has been hit hard by opioids. Not only are construction workers at greater risk of opioid overdose than people in other occupations, but many overdoses occur in or near job sites. Fortunately, many construction workers now have access to naloxone -- a safe, overdose-reversing medication.

Naloxone can save a life



Naloxone nasal spray (also called NARCANTM) can reverse an overdose caused by opioids such as heroin, fentanyl, and prescription painkillers. It is even easier to use than an EpiPenTM and is safe to use even if opioids are not the reason someone is non-responsive.

If you suspect that an unresponsive person may be experiencing

an opioid overdose, you can administer naloxone without negative consequence to that person or yourself. If the person has not taken opioids, naloxone will not hurt them. In the U.S., Good Samaritan Laws have been created to help protect those trying to help reverse an overdose (check your state's law for details). Also, you are not at risk of opioid exposure from skin contact or exhaled breath from someone who is experiencing an overdose.

NARCAN Quick Guide

Is someone unresponsive with slow or stopped breathing?

They may be experiencing **an opioid overdose**.

Call 911. Tell them you have an unresponsive person.

Administer naloxone nasal spray. Give a second dose if they do not respond.

Do not test the device: it can only be used once. No assembly is needed. Spray the naloxone in one nostril by pushing the plunger.

If they are still unresponsive, administer CPR until help arrives.

Responding When Someone May Be Suffering an Opioid Overdose

Signs of an opioid overdose include:

- Unresponsiveness or unconsciousness •
- Slow or stopped breathing
- Blue, gray or white lips or fingertips
- Snoring or gurgling sounds •

There are several responsiveness checks you should do before giving naloxone:

- Shout loudly to see if the person responds.
- If there is no response, grind your knuckles into their breastbone (sternal rub).
- If there is no response to the sternal rub, call 911 and administer naloxone nasal spray following package instructions.

If you think someone is suffering an overdose, take these steps:

- 1. Call 911 for medical help. Tell them you have an unresponsive person with slow or stopped breathing.
- 2. If the person is unresponsive and not breathing, and you are trained in cardiopulmonary resuscitation (CPR), immediately begin CPR. Use an automated external defibrillator (AED) when available following the instructions on the AED. Do not give CPR to a person who is breathing regularly or who is awake.
- 3. Give naloxone nasal spray following the package instructions. Do not test the device, as it can only be used once. No assembly is needed. Spray the naloxone in one nostril by pushing the plunger. If there is no response, give a second dose with another naloxone dose kit. Naloxone can take a few minutes to work. Providing CPR or rescue breaths can help to save a life.

After giving naloxone:

- 1. Stay with the person until medical help arrives. Let them know that you have given them naloxone.
- 2. Keep the person from getting cold or overheated.
- 3. After administration, naloxone is active for 30 to 90 minutes and may cause withdrawal symptoms until it wears off. It is possible for the person to experience the overdose again as the naloxone wears off. Opioids last longer in the system than naloxone. This is why getting medical assistance is important.
- 4. Due to withdrawal symptoms, some people may be very agitated or uncomfortable.
- 5. Opioids are commonly mixed with other drugs that naloxone will not reverse.
- 6. Get more naloxone as soon as possible to be prepared for the next event.



He showed me how to strive at every turn to improve the lives of the men and women who work at our craft. He was my mentor and moral compass. 




Local 2 Hosts Health Fair

Unlawful Harassment in the Workplace

At our Thirtieth Convention, Resolution 31 regarding harassment, discrimination and bullying in the workplace was adopted by the delegates present. As a result, the International Union has adopted the following policy statement, which reads:

"The United Union of Roofers, Waterproofers and Allied Workers Union and its subordinate Local Unions are committed to providing all its employees and members a workplace free from bullying, discrimination, and harassment.

This Union does not discriminate against or allow any action to be taken against any individual based on their race, ethnicity, religion, color, sex, age, national origin, sexual orientation, disability, gender

In addition, the resolution requires each subordinate local union to read the adopted policy statement at least once yearly at a monthly meeting of its choosing.

As members of the United Union of Roofers, Waterproofers and Allied Workers, it's essential that we all come together to adapt to the evolving expectations of

identity or expression, ancestry, pregnancy, or any other basis prohibited by law, or based on the employee's protected activity under the anti-discrimination statutes.

This Union emphatically reaffirms that it will not tolerate bullying, discrimination, or harassment in any form. This prohibition covers any activity in the workplace, regardless of whether the bullying, discrimination, or harassment is committed by a union officer, union member, union employee, or nonemployees such as a vendor, consultant, or employee or officer of an affiliate, or invitee to a Unionsponsored activity, event or meeting.

Our organization calls on all individuals and organizations to join us in adopting this statement and to take active steps towards promoting an inclusive and respectful environment."

Minutes of the Indiana District Council

The meeting of the Indiana Roofers District Council was held February 6, 2025, at Roofers Local 119 in Indianapolis, IN.

International Reports

International Vice President Joe Pozzi reported on federal and local anti-union bills, emphasizing the importance of member education for continued growth. He discussed his assistance with other locals and stressed the importance of educating members on labor issues.

International Representative Kevin King provided updates on his work with Local 97 to restore stability. He reminded members about the proper usage of union credit cards and the importance of returning personal checks to the local per by-laws. He stressed compliance with Resolution 31 (Anti-Harassment) and urged locals to update their constitutions and by-laws every five years. He also encouraged registration with Helmets to Hardhats to expand workforce opportunities.

Delegate Reports

Marcus Bass, Local 26, reported on updates to local bylaws, the addition of eight new crane operators, and 12 members pursuing Class A CDLs (five have completed the course). He announced the apprenticeship competitions will be held in St. Louis on August 23, 2025, and discussed contractor issues.

Scott Cooper, Local 26, spoke on grievance filing procedures and best practices. He attended a Skills-USA event at the Carpenters hall, where commercial roofing classes were being conducted. He discussed local contractor challenges, membership concerns, and preparations for the upcoming election.

Clint Grayless, Local 150, reported on successfully conducting his first OSHA 30 class. He discussed upcoming work at a battery plant with an out-of-jurisdiction contractor, securing 14 members for the project. They have a good number of new apprentices in this year's class. He expressed optimism about winning the Martini Award again.

Brian Smith, Local 119, said work outlook for the year is strong with record-breaking hours. He addressed contractor disputes, local legislative challenges, and strategies to address House bills affecting labor. He also noted apprenticeship enrollment.

Heath Griesmann, Local 42, shared insights from his apprenticeship experience, highlighting a third-year apprentice advancing to the finals in Minneapolis. He is working on training initiatives for the new apprenticeship instructor and preparing for a business management role.

Charles Waddell, Local 23, reported that work is picking up rapidly. He discussed plans to purchase a dedicated building for local and apprenticeship use and reviewed key points from the last meeting.

At this time Scott Cooper read the financial report. A motion was made, seconded, and carried to approve the report. A motion was made, seconded and carried to suspend Local 150's per capita payments for one year.

A motion was made, seconded and carried to purchase new district council shirts.

There being no further business, the meeting was adjourned at 1:33 p.m.
